TO BE COMPLETED BY SALON OWNER

I, as the owner of the salon that this suite or chair is located, understand that the person renting this space is an independently operated business.

I do not control the daily operations of the suite or chair, and have a written contract with the individual regarding the rental agreement.

Independent licensee is not treated as an employee under the terms of the Internal Revenue Service.

As the holder of the salon license, the Independent Licensee is responsible for the sanitation of the salon premises. If an Independent Licensee does not have a valid, current license, that space falls under the salon license and Salon Owner, would therefore be responsible for sanitation of that space.
